

### **TERMS OF USE AGREEMENT**

Welcome to www.aac.ca (the "Website"), owned and operated by The Alberta Student Assessment Network, operating as the Alberta Assessment Consortium ("AAC"). By accessing and using the Website, you are agreeing to comply with and be bound by this Terms of Use Agreement (the "Agreement"). Please read the following Agreement carefully. If you do not wish to be bound by these terms and conditions, you may not access or use the Website. AAC may modify this Agreement from time to time, and any such modifications shall be effective immediately upon posting of the modified Agreement on the Website. You agree to review the Agreement periodically to be aware of such modifications and your continued access or use of the site shall be deemed your conclusive acceptance of the modified Agreement.

The provisions of this Agreement restricting the unauthorized use or copying of Materials apply to all users of this Website, including members of AAC ("AAC Members") and their respective employees (including teachers), consultants, contractors, or other representatives. These terms do not replace, but are in addition to, the terms governing a Member's membership rights.

Educators who are employed by AAC Members and who are on secondment to a jurisdiction or organization that is not an AAC Member do not retain the rights afforded to AAC Members during the term of their secondment, and their access is limited to that which is available to the public. Educators who were formerly employed by AAC Members and who are no longer employed by an AAC Member do not retain the rights afforded to current AAC Members.

#### **Electronic Communications**

By accessing and using the Website or sending us e-mail, or otherwise communicating with us electronically, you are granting your explicit consent for all purposes, including for the purposes of any applicable anti-spam or comparable legislation, to allow AAC to communicate with you electronically, and any agreements formed (including, without limitation, agreements for the purchase of educational materials) by electronic communication between you and AAC will be valid in that form.

#### **Use of AAC Materials**

AAC materials accessible through the Website include:

prior written consent of AAC or other applicable copyright holder. AAC Members may view, copy, print and use AAC Member Materials only as specified within such AAC Member Materials or otherwise on the Website, and you expressly agree that you will observe and comply with any notice or restriction on or accompanying any AAC Member Materials.

No Materials may be viewed, copied or used for any commercial application intended to generate financial profit for the user thereof, or for any organization to which such user may belong or be seconded, or by which such user may be employed (a "**Commercial Use**"), except as specifically provided herein.

Without limiting the generality of the foregoing, the following specific provisions shall apply:

- <u>AAC Publications:</u> AAC Publications may be purchased through the Website, and may not be copied, stored, reproduced, distributed, republished, downloaded or transmitted in any form or by any means.

- <u>Documentary Materials that are AAC Member Materials:</u> Documentary Materials that are AAC Member Materials ("AAC Member Documentary Materials") may be viewed, printed, copied and used for classroom instruction and professional development, provided that you are responsible to ensure that any copyright notice along with any other notices and disclaimers appearing on such AAC Member Documentary Materials are reproduced and retained on all copies in the same form and manner as on the original. AAC Member Materials may not be used for a Commercial Use without the express written permission of the copyright holder.
- AAC Member Documentary Materials may be downloaded, copied and stored on individual computers, but may not be sent to, forwarded to or shared with any other parties who are not AAC Members, nor may AAC Member Documentary Materials be uploaded to, copied to, stored on or through, or posted to any external websites other than the Website.
- AAC Member Documentary Materials that have been downloaded, copied or stored as described in the preceding paragraph may be shared in classroom presentation or in print form with students of the AAC Member. As an exception to the above, due to the cancellation of in-school classes in March 2020 as a result of the COVID-19 health emergency, individual teachers from AAC member jurisdictions may post AAC performance assessment tasks and tools to an electronic platform that is intended for use by the students/families in their own class, or to send AAC performance tasks and tools through email to the students/families in their own class.
- AAC Member Documentary Materials may be modified for individual instructional use and professional development by individual teachers employed by an AAC Member, provided that each page or slide that has been so modified displays the following statement, along with the uniform resource locator ("URL") linking to the original source on the Website:

- <u>Documentary Materials that are available to the public:</u> Documentary Materials that are available to the general public ("Public Documentary Materials") may be viewed, printed, copied and used for classroom instruction and professional development, provided that you are responsible to ensure that any copyright notice along with any other notices and disclaimers appearing on such AAC Member Documentary Materials are reproduced and retained on all copies in the same form and manner as on the original. Public Documentary Materials may not be used for a Commercial Use without the express written permission of the copyright holder.
- Public Documentary Materials may be downloaded, copied and stored on individual computers, but may not be uploaded to, copied to, stored on or through, or posted to any external websites other than the Website.
- AAC Public Documentary Materials that have been downloaded, copied or stored as described in the preceding paragraph may be shared in classroom presentation or in print form with students an individual teacher. As an exception to the above, due to the cancellation of in-school classes in March 2020 as a result of the COVID-19 health emergency, individual teachers may post AAC performance assessment tasks and tools that are part of the Public Documentary Materials to an electronic platform that is intended for use by the students/families in their own class or to send such AAC performance assessment tasks and tools that are part of the Public Documentary Materials through email to the students/families in their own class.

Where you have password-protected access to the Website as a result of being an AAC Member, you shall not disclose such password to any person not an AAC Member.

#### **Remedies for Breach**

In addition to and without limiting any remedies AAC may have at law or equity pursuant to any infringement of copyright or other breach of the terms of this Agreement, AAC may restrict or refuse access to the Website to any person or organization, including an AAC Member or employee of an AAC Member, where AAC, in its sole discretion, determines that such AAC Member or employee has breached the terms of this Agreement, or otherwise poses a risk to the integrity, reputation, or operation of the Website or of AAC.

The Website may contain links to third party websites.
